1. Approval of 2006 Business Meeting Minutes
2. Treasurer's Report - Donna Martineau - Our balance as of Aug. 5, 2007 is \$3224.33. Our balance from Aug. 1, 2006 was 2738.53.
3. Apprentice Chairman's Report - Jerry McDougal - Seven new members this season, very few new apprentices, we need to get the word out to build our numbers.
4. Supervisor of Officials' Report - Bill Tirone - \$132.00 for JV & varsity, 2008 \$78.00 for varsity. Schools will pay \$10.00 extra if you travel 40+ miles one way, \$20.00 for 60+ miles. Dick will try to move some people to save schools on extra travel.

Please let Bill know if you are scheduled to work a tournament game with a team you are affiliated with. This should not happen.

5. Rules Interpreter's Report - Rick Forge - We are the highest paid officials in the country! Read your rulebook. There were many unacceptable rule misinterpretations last season. We need to do better.

Reminders: It is ok if the libero wants to go through the line and shake hands with the opposing team before the match begins. Also remember there is no cap on any game, the winning team must win by 2 points.

Don't forget, the JV match is always 3 games, the first 2 games to 25 points, the last to 15 points, all with no cap.

6. Assigner's Report - Dick Dumais - All matches have been assigned, except for a few Prep schools. Wilton girls and Souhegan boys have no JV teams.

8. New Business - We are moving the business meeting to 10:00am next August, before the rules interp.

NHIAA is working with Federation to cover all officials starting next year with insurance for a fee of \$15.00 per member, which is about what we are paying now.

Donna is also looking for ball pumps with a gauge and has found one, but it is only sold in Europe! She has placed a small order and is waiting to check the quality and how long it takes to get them. She will keep us posted.
